**RE: BID PROPOSALS FOR RUSCH PARK RESURFACING OF PICKLEBALL COURTS**

The Sunrise Recreation and Park District is soliciting proposals to resurface six (6) current pickleball only courts within the District at Rusch Park. The crack filling, resurfacing and striping will be required as needed on all 6 current pickleball only courts. Please see the scope of services for additional details.

#### **SCOPE OF WORK**

The Contractor shall perform, furnish and complete the following under one contract:

#### **Rusch Park- Six (6) current pickleball only courts Numbers 4, 5, 6, 10, 11, and 12.**

Provide all materials and labor needed to complete the following:

- Sand down entire court surface.
- Fill all cracks with crack filling material as needed.
- Remove all dirt, debris, and any loose surface material.
- Apply two (2) coats of acrylic base coating to entire court surface.
- Apply two (2) coats of acrylic court color coating (with sand added\*) to entire court surface.
  - Two (2) coats of "Stadium Blue" (with sand added\*) for inside playing surfaces.
  - Two (2) coats of "Grass Green" (with sand added\*) for surrounding areas.
    - Layout and stripe six (6) Regulation Size Pickleball Courts with two (2) coats of white paint to official layout.
- **\*Combination surfacing is acceptable\***
- **\*Products to be Nova Sports or Acrytech\***
- **\*Prevailing wage included\***

All work shall be performed per the plans and specifications and as per Sacramento County Construction Standards, January 2008. The contract price shall include full compensation for all equipment, materials and labor to complete all work as specified herein and no additional compensation shall be allowed.

**EXISTING CONDITIONS**

The vendor, in undertaking the work under this contract, is to have visited the premises and to have taken into consideration all conditions which might affect the work. No consideration will be given to any claims based on lack of knowledge of existing conditions. There will not be a pre-bid walk.

**DEVIATIONS**

Any deviations from the scope of work indicated herein must be submitted in writing to the project manager prior to the bid due date.

**VALID CALIFORNIA CONTRACTOR'S LICENSE** - Required at time of bid submission and valid through the length of the project.

**PREVAILING WAGE** - Pursuant to the California Labor Code Section 1720 and following this is a prevailing wage project.

**DIR REGISTRATION** - All contractors and subcontractors must register with the DIR and meet DIR requirements before bidding on public works contracts in California.

**SUBMITTALS** - None.

The Board reserves the right to reject any or all bids, to waive any informality in any bid, and to determine which bid, in the judgment of the Board, is the lowest responsive bid of a responsible bidder.
